Administrative Burden Research Update

Discovery Focus

Uncover outdated and inefficient reporting processes and elevate opportunities that could level set the undue burden experienced by public behavioral health providers.

What goals do we have?

- 1. Increased understanding of how BHA reporting mandates (specifically CCAR/DACODS) influence provider processes and operations.
- 2. Recommendations for improving data quality and reducing administrative burden on providers.



Research By The Numbers

- Engaged with **16 providers** across a variety of tech setups, geographies, mental health settings, services offerings, and population expertise.
- Talked with over 60 individuals in a range of roles from clinicians, administrative staff, data/tech teams, managers, and leadership
- Spent close to **30 hours** in internal and external interviews and virtual site visits



"When thinking about updates to data reporting, consider how you would want yourself or a family member treated in an initial intake. The current state of the reporting requirements interrupts clinical flow (directed vs. open-ended questions, lack of data entry flexibility) and don't match up with patient-centered, trauma-informed best practices."

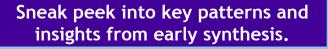
