# **Technology Updates**

#### Client Care Search



A system where inpatient and residential behavioral health providers track their bed availability, and where care navigators can find information for client placements. Client Care Search tool is defined by Colorado Revised Statute 27-60-104.5.

#### Recent Updates NEW



We will be running a pilot with 3-5 provider organizations in September testing out new care coordination features

## By the Numbers

- Client Care Search live ~60 days
- **76**% compliance with daily bed updates
- 85 provider locations

## PEAKPro trainings

- PEAKPro is the tool you will need to verify client Medicaid and income status, and/or get the required Medicaid or State ID needed for encounter reporting.
- Training has previously been instructor led over 3 sessions.
- We are currently moving training to a self paced course, which will take about 90 minutes to complete.
- We are currently in a limited pilot phase and will launch more broadly soon.
- New trainings are temporarily paused while we make this shift.
