- Improved our data ingestion, analysis and presentation for providers through our technology partner Snowflake.
- Updated our licensing system LADDERS.

 - Bed tracking
 - Inpatient / residential referrals
 - Peer navigation
 - Data reporting and administrative burden.




LADDERS (BHA Licensing System) Update


LADDERS Updates
